Sample Collection Instructions

1)If sending **just hair** now, please send 30 to 40 hairs pulled (not cut) with root bulbs attached. Please bind bundle at the middle with tape or rubber band and place in labeled zip lock baggy. Fill out form, include sample, include payment and mail.

2)If sending **just blood** now, please send 3ml whole blood in EDTA (purple top tube) labeled with the horse's name and, if applicable, name of veterinarian. Rock tube 20 times to mix. No chilling or freezing necessary in shipment. Fill out form, include sample, include payment and mail.

3)OR if you prefer to **receive** a blood tube or a cheek swab/hair kit from VetGen, please fill out this form and include Visa / Master Card information or Check or Money Order for the appropriate amount. We will mail you an oral cheek swab plus hair sample collection kit (test price includes kit) or a blood tube kit (PLEASE SPECIFY WHICH YOU WOULD LIKE TO RECEIVE).

VetGen, LLC Terms and Conditions

1. **Binding Terms:** These Terms and Conditions shall govern the testing services provided to the undersigned customer ("Customer") by VetGen, LLC ("VetGen") in accordance with the DNA Test Sample Submission Form. This is a legally binding agreement between Customer and VetGen.
2. **Samples:** VetGen will handle and store all samples sent by Customer with due care. All samples sent to VetGen shall become the sole property of VetGen. VetGen shall have no obligation to return or store any samples sent by Customer once VetGen has completed the testing services.
3. **Nonconformance of Services:** Within twenty (20) days after Customer receives the test results from VetGen, Customer must notify VetGen in writing of any nonconformity of the testing services, describing the nonconformity in detail, otherwise all testing services and data shall be conclusively deemed accepted by Customer without qualification. Customer's sole and exclusive remedy for the nonconformance of testing services performed by VetGen is described in Section 4 below.
4. **Limited Warranty:** VetGen warrants that any testing that it performs for Customer pursuant to the DNA Test Sample Submission Form will be performed in accordance with generally accepted industry standards of care and competence. Customer's sole and exclusive remedy and VetGen's sole and exclusive liability under the foregoing warranty shall be either to re-perform the testing or provide Customer with a refund for the testing as solely determined by VetGen. VetGen will bear all reasonable shipping costs if testing is to be re-performed. To the fullest extent permitted by applicable law, VetGen disclaims all other representations and warranties, expressed or implied, with respect to the testing services performed by VetGen including but not limited to any implied warranties or merchantability, fitness for a particular purpose, accuracy, or infringement. Customer's sole remedy for breach of warranty is limited to those remedies as stated above.
5. **Additional Liability Limitation:** To the fullest extent permitted under applicable law, VetGen shall not have any liability for any incidental, compensatory, punitive, consequential, indirect, special or other damages, including but not limited to loss of use, loss of income, lost profits, loss of time, loss of sales, injury to personal property, any liability Customer incurs with respect to any other person, or any other type or form of consequential damage or economic loss however caused and regardless of form of action whether in contract, tort, including negligence, strict product liability or otherwise regardless if VetGen has been advised of the possibility of such damages. Customer understands that any risks of loss hereunder are reflected in the price of the testing services and that these terms would have been different if there had been a different allocation of risk.
6. **Indemnification:** Customer further agrees to indemnify and hold VetGen, its affiliates, shareholders, directors, employees, agents and its successors and assigns harmless from all costs, claims, charges, losses, damages, expenses, liabilities or civil proceedings of any kind, including reasonable attorneys fees, arising from or related to any third-party action or claim brought against VetGen related to its performance of testing services for Customer.
7. **Governing Law:** These terms and conditions and the testing services provided by VetGen shall be governed by and construed in accordance with the laws of the State of Michigan, USA without regard to its conflicts of law provisions. Customer hereby consents to jurisdiction of the courts of the State of Michigan, USA and waives any objection to venue in Washtenaw County.
